For the other, I drove two hours to meet the team at their factory in person. These early interactions helped us understand their needs and scope the work effectively.

After submitting our proposals, we had some brief pricing discussions and then agreed terms. I assigned the work to team members best suited for each job and ensured regular follow-up to guarantee timely, high-quality delivery.

Investing time in building real relationships, whether over a call, a coffee, or a factory visit, is what makes the MGI Worldwide network so powerful.
